NaCSA RECEIVES A SATISFACTORY RATING FROM THE WORLD BANK AND UNICEF

The World Bank Implementation Support Mission has on Thursday October 26, 2023 presented its findings to the Government of Sierra Leone. The event took place at the Freetown City Council Hall. It could be recalled that the World Bank commenced the implementation support mission to "review, identify, and address bottlenecks to accelerate the closure of the Social Safety Nets Project and the Implementation progress of the Productive Social Safety Net and Youth Employment Project and support the finalization and submission of relevant documents including the Project Implementation Manual and Emergency Response Manual to reach effectiveness."

Having received updates from government institutions that contributed to the implementation of the Covid-19 Ep Fet Po/Social Safety Nets and those currently implementing the Productive Social Safety Nets and Youth Employment (PSSNYE) project, the World Bank Implementation supports mission has informed the Government and the people of Sierra Leone that the completed SSN project has been rated satisfactory.

In his presentation, Dr. Abu Kargbo, World Bank Senior Social Protection Specialist expressed the Bank's satisfaction with the SSN implementation. "...we are happy that the Government of Sierra Leone has successfully implemented the Social Safety Nets Project with a satisfactory status. We have further noted that there is no evidence of misappropriation of project funding. We want to see similar commitments during the implementation of the PSSNYE project." He ended. The UNICEF representative re-echoed UNICEF's unflinching support to the government and people of Sierra Leone with keen interest in the person with disabilities and children.

The Minister of Gender and Children's Affairs, Dr. Isata Mahoi stated that the SSN and PSSNYE projects are at the

centre of her heart and promise to work collaboratively to ensure smooth implementation. We are looking forward to the project to include women and girls in the implementation of the project. "We called on the team to ensure that the Grievance Redress Mechanism (GRM) is effective and functional. This is particular for our women and girls; Gender! Gender!" she ended. He promised that the team would ensure speed in delivery while ensuring value for money.

Director Sandi also disclosed to the people that the PSSNYE project is an approved Forty (\$40) Million Dollar project by the World Bank, for five years with components such as, Cash Transfers and Provision of Economic Inclusion Support, Productive Labor Intensive Public Works and Life Skills Support for Youth, Employment and Entrepreneurship Support for Youth, Systems Development and Coordination, GRM and citizens engagement and Contingency Emergency Component.

He encouraged the people of Bongor and the youth category to ensure the project succeeds amidst any unforeseeable challenges.

Dilating on the Grievance Redress Mechanism (GRM) component of the project, Michael Sesay, Head of Public Education Unit, ACC, said the ACC was empowering communities on the PSSNYE so that they will know exactly what constitutes the project and the role of ACC in its implementation. He assured listeners of ACC presence in all stages even at Post Monitoring stage in order that the ACC would understand what had transpired at the time of the recent cash payments. Mr. Sesay implored his audience to take the project seriously as it will positively change their present state of poverty and also transform their lives.

Elaborating on the people's role and the Commission's expectations, Public Education Officer ACC, Christiana F. Jusu said that they are to utilize the funds properly in order to meet the Donors' intentions and the project objectives. She urged them to report any incidences of corruption to the ACC on toll-free lines 077-985-985 or 077-986-986 for prompt actions and interventions.

Madam Jusu further highlighted the many success stories of ACC interventions into the then SSN project, emphasising that those measures will also be infused into the now PSSNYE for successful implementation.

In his submission as Chairman of the engagement, Andrew Forbie, Data Analyst, ACC, reassured the people of ACC's alertness at all times, noting that the people must not allow or entertain any authority or stakeholder to undermine the project. He also informed them of the GRM in the Agriculture project, which the ACC is poised to ensure that the tenets of integrity and transparency are at the heart of its implementation.

The presentation of the Information, Communication, and Educational materials for distribution to the diverse sections and beneficiary communities of the PSSNYE project climaxed the engagement.

NaCSA ON PRESIDENT BIO'S FEED SALONE FLAGSHIP PROJECT FEEDER ROADS LINK FARMS TO MARKETS



Kumrabia to Mabang, and Matuku 2 to Mafolatha under rehabilitation by the SLCDD II

NaCSA on President Bio's Feed Salone Flagship Project Feeder Roads link Farms to Markets ensuring that farmers realize profit from their labour and are incentivised to expand and grow more crops. Currently 150 kms are under rehabilitation in Lower Bambara- Kenema, Ribbi and Bagruwa in Moyamba, Khalifa Mabang and Kunike Sanda Tonkolili, BKM Port Loko and Dibbia Karene. The SLCDD II project is funded by IsDB and GoSL.

Other major components of the project are Model markets/Community Resource Centers and Mutirenewable energy mini grids and Water irrigation and water conservation systems. The Water Conservation and Irrigation Systems are meant to ensure farmers grow crops throughout the year. Kudos to Commissioner Ernest Mbaimba Ndomahina and NaCSA management.

NaCSA PROVIDES BAGRUWA HUB WITH NINE THOUSAND PIECES OF FINGERLINGS FOR THREE FISH PONDS NEWLY CONSTRUCTED

In continuation in its drive to make available good quality fresh fish that will provide affordable fish protein to the poor and fast growing rural population, NaCSA, through its SLCDD II Project has on Wednesday 25th October 2023 supplied the Bagruwa HUB with nine thousand pieces of fingerlings for three fish ponds newly constructed at Gbangbatoke Junction, and 15 bags 50kg concentrate feeds for the above mentioned ponds from Alumair Investment (SL) Limited. This will also reduce the pressure on capture marine environments.
