NaCSA AND UNICEF COMMIT TO DEVELOP OPTIONS FOR CASH+ PROGRAM-MING TO REDUCE EARLY PREGNANCY AND CHILD MARRIAGE

The National Commission for Social Action (NaCSA) and the United Nations International Children Emergency Funds (UNICEF) have on Tuesday November 7, 2023 commenced a two-day Consultative Workshop to develop a Cash Plus Program for the prevention of Child Marriage through Social Protection. The workshop which was held at the Occasions Enterprises, Lakka Beach Road brought together a diverse group of experts, including government and private sector officials to discuss and suggest a design of a Cash-plus Social Protection program that will seek to prevent child marriage, improve the lives of girls, and ensure a brighter future for our nation.

It could be recalled that the Productive Social Safety Nets and Youth Employment (PSSNYE) initiative has been put into action by the government of Sierra Leone and its development partners. The government's focus on providing integrated services for disadvantaged households is one of the project's main goals. Similarly, the PSSNYE project may also be used as a foundation for the addition of more cash-plus components aimed at addressing the causes of child marriage as well as services that support the safe transition of girls into adulthood.

The NaCSA Social Development Specialist for NaCSA, Md. Isata Blake called on participants to own the discussions primarily because the products of the engagements are for the betterment of Sierra Leoneans especially the most vulnerable. Mona Korsgard, Chief of Evidence, Policy and Social Protection for UNICEF Sierra Leone expressed her satisfaction over the turn-out by subject matters experts. 'We have gathered people to discuss how we can broaden Social Protection to reach the extremely poor and how it can be a tool to fight against early marriage and teenage pregnancy. As always, you are assured of the unrivalled commitment of UNICEF.' She ended.

MsLiv ElinIndreiten, UNICEF Deputy Representative (programme) congratulated the government and people of Sierra Leone for the tremendous progress in social protection. She noted that ' Integrated inclusive social protection programmes can help these girls. International evidence demonstrates that cash transfers have a positive impact on children's and adolescents' school attendance and can support adolescents in making a safe transition to adulthood. There is also evidence from African countries that women beneficiaries of cash transfers became less exposed to intimate partner violence, and adolescent girls benefiting from cash-plus programmes - which link cash and services such as life-skills education - are less vulnerable to sexual exploitation. The workshop today is to discuss possible ways of leveraging the social protection system to achieve the objectives of preventing child marriage and teenage pregnancy. Our consultant Qimti will facilitate the discussion, and I encourage you all to participate actively." Shed continues.

The Commissioner of NaCSA, Ambassador Ernest Mbaimba Ndomahina emphasized the importance of cash-plus programs in social protection especially in the form of cash assistance programs to extremely poor communities. " Most often, cash plus interventions are conditional transfers to help poor families comply with essential responsibilities such as school attendance and retention. With this workshop, we intend to explore initiatives for cash plus support to extremely poor families to help them cope with some of the odds of social norms; early marriage and teenage pregnancy." He stated.

The Commissioner further expressed that the government team is hopeful to combine the Unconditional cash transfers of the ongoing PSSNYE project with Cash Plus.

' Much will be obtained in achieving key programme objectives. We will be able to get families to educate their children, especially the girl child and position them to meaningfully contribute to human capital development. With this in mind, I declared this workshop open.' He ended.

NaCSA COMMISSIONER LAUNCHES THE FOOD SYSTEMS RESILIENCE PROGRAMME (FSRP) PAYMENT TO BENEFICIARIES IN BO DISTRICT

In response to the economic crises caused by the war between Russia and Ukraine, the government of Sierra Leone with support from the World Bank is implementing the Contingent Emergency Response Component (CERC) through NaCSA and the Ministry of Agriculture and Food Security (MAFS).

Given that NaCSA has the systems to implement cash transfer programs, MAFS contacted the Commission to implement the CERC component of the Food System Resilience Program (FSRP).

The CERC of the FSRP is an Emergency Cash Transfer (ECT) to 12,000 extremely poor populations residing in flood-prone areas in 12 districts including BO, Kenema, Bonthe, Kailahun, Pujehun, Moyamba, Tonkolili, Port Loko, Karene, Falaba, Koinagdu and Kambia.

Each beneficiary will receive a cash amount of NLe2600 to afford basic needs. Hopefully, the benefit will assist the poor to provide good food, afford transportation to access medical facilities when sick, and if possible use it as business start-ups to enhance livelihoods.

Chief Ndomahina emphasized the importance of the local council in implementing community driven projects.

It could be noted that Agriculture remains to be the back bone of the Sierra Leone's economic development. One time referred to as the socioeconomic engine of the country, Agriculture employs over 70% of the total population in the country. However, there are several challenges and prospects facing the Sierra Leonean farmer in his strive to make living. Some of these challenges are deep rooted in the believe system while others include the lack of requisite inputs equipment, quality seeds and technical knowhow.

Agriculture is a special field of social activity which is closely related to important issues like ensuring food security and nutrition of people, creating scope of income and poverty alleviation. These cross-cutting themes make the field more worthy to report on. It is therefore important for the media to give more attention to agricultural reporting if this sector (which employs the bulk of the country's population) is to flourish.

For instance, in climate change reporting, weather forecast may help the farmers to prepare in several ways; information about the environment, preparation for planting or harvesting alertness in terms of farming and marketing, and adaptation to climate change, to name a few. This is so, as the media is part of social change process in terms of awareness RAISING, generating mass INTEREST and discussing change influence or impact on people.

Therefore a strong, honest, accountable and exclusive agricultural journalism/reporting can solve the problems of belief patterns and sufferings of the people originated from this sector. It is no doubt that, if this is realized, the vision of the current government to feed Salone could be achieved and sustained.

NaCSA COMMISSIONER USHERS BMZ AND KfW MISSION IN THE FIELD

NaCSA Commissioner Amb. Ernest Mbaimba Ndomahina has on Friday, November 10, 2023 led a delegation from BMZ, KfW, GIZ and staff of the German Embassy in Freetown on a day mission to Kambia District.

In Kambia, which is one of the five operational districts of the NaCSA implemented GPC III Project, the delegation was received by the Chief Administrator of the Kambia District Council, Dr. Edward Alpha, who thanked the Commissioner for the thought of paying the Council a courtesy call. Something he noted, is very rare among other partners.

Dr. Alpha commended the GPC III project and affirmed that they are greatly relieved by its operations and interventions in the district. Kambia District, he furthered, is a Rice predominant district. Despite its ecology, the district used to suffered hording which made the price of rice the highest in the entire country. Key factor for this, he noted was the deplorable conditions of the roads. As a result, he said made farmers to take their produce into neighbouring Guinea.

The coming of the GPC III project in the district, he confessed has change the narrative. Because of the GPC interventions, especially in the area of feeder road rehabilitations, which have inevitably opened access between the farms and the markets centres, there are significant benefits for both the council

and the communities. These, he said cut across revenue generation for the council and increase production for the farmers. Based on its achievements, the Chief Administrator ended up pleading for the project to stay in Kambia.

For NaCSA, the Council is a key strategic partner. In his statement at the Council, the Commissioner of NaCSA, Ambassador Ernest Mbaimba Ndomahina thanked Chief Administrator his warmth welcome and registered NaCSA's appreciation and commitment in working with the council. In demonstration of this, the Commissioner presented a bottle of water and kola nut, while requesting the Council's permission to embark on the mission at key project implementation sites in the district.

In her contribution, the Head of Delegation for the Mission, Dr. Sabine Lindemann, disclosed that Germany has been by the side of the Government and people of Sierra Leone since 2013, immediately after the civil war. The GPC project, she noted has been in operation in Sierra Leone for eighteen (18) years and has focused itself on peace consolidation. On the objective of the mission, she affirmed is to assess the implementation progress, while planning for another phase for the project. This time round, she noted, they will be linking the GPC with the Employment Promotion Programme (EPP) in order to add value to their interventions.

Forming part of the Mission were visits to key project implementation sites, including the GPC III Feeder Road rehabilitations, Grain stores at Gbonkomaria and Rokel villages and held meetings with members of the Facility Management Committees respectively.
